

# Attention Exhibitors!

**All Shavings MUST be ordered through Queen Wood Sales at the GIHP. The GIHP requires INITIAL bedding of 2 bags per stall. No initial bedding will be added to your entry. Order initial bedding and additional bedding in ADVANCE from Queen Wood Sales. Contact Rob Robbins at 770-860-9111 (office) or 678-416-1424 (cell) or queenwoodproduct@bellsouth.net. Shavings ordered in advance of the show will be waiting at your stalls when you arrive. Rob also handles golf cart rentals.**

## Facility Rules for the Georgia International Horse Park – Conyers, GA:

- ❖ No Smoking allowed within the confines of the GIHP facility. This includes Barns, Arenas, Show office, retail shops or any vehicle owned by GIHP
- ❖ Exhibitors shall not use nails or screws for attaching decorations or hanging tack, supplies, feed buckets, etc. in stalls. Exhibitors may use cable ties, duct tap, over stall hangers, pushpins or small staples. It is the responsibility of each exhibitor to remove these items upon load-out
- ❖ Golf carts and other motorized vehicles are permitted on concrete and aggregate material roads only. No golf cart or motorized vehicle shall be permitted in the barn aisles, training arena, competition arena, grass area, or spectator area. Golf carts and motorized vehicles shall be operated in a safe and cautious manner at all times by a licensed driver 16 years of age or older.
- ❖ All pets must be kept on a minimum 6 ft leash at all times and are the owners' responsibility. Pets are not allowed inside any GIHP enclosed facility. **INCLUDING RESTROOMS!!**
- ❖ Only authorized personnel may operate GIHP equipment.
- ❖ No Littering
- ❖ GIHP strictly prohibits fireworks, illegal drugs, firearms, glass bottles, air horns and any other items that may distract from the safety and enjoyment of exhibitors and spectators.
- ❖ No tents shall be erected or any anchor stakes placed without express approval from GIHP management.
- ❖ No heating appliances shall be used in the barns except in designated areas.
- ❖ Horse washing is prohibited in the barn aisles.
- ❖ Lungeing is permitted in the lungeing rings. Lungeing is strictly prohibited in training arenas, competition arenas and grass areas. The show will be fined \$100 for each occurrence if violated.
- ❖ Horses are prohibited in the public spectator area, food service area, and covered arena courtyard.
- ❖ Temporary electrical cords must be of the 3-wire type and suitable for intended use.
- ❖ All manure removed from stalls must be placed in designated areas, not trashcans.
- ❖ Straw is not allowed for bedding. Stall Bedding: A minimum of two bags of shavings is mandatory for all occupied horse stalls. A \$20 fee may be assessed to the show for stalls that have straw bedding. Queen Products will supply shavings. Arrivals after 6:00 pm must call and pre-order by 2:00 pm before the day of arrival.
- ❖ All bio-hazardous material must be properly disposed in required bio-hazard receptacles.
